





COVID – 19


- Elective surgery:
 - Significantly impacted by staff shortages mainly in public hospitals.
 - Shortage of staff have been a major issue.
 - Ad-hoc elective list cancellations more recently.
- Winter Surge:
 - The increase in winter surge of admission is expected to further impact the provision of emergency and elective surgery.
- ACT Health:
 - Purchasing bed capacity in the private sector.
 - Public in the Private elective surgery.



COVID - 19

RACS ACT:

- Advocating for medium to long term solutions to address pre-existing theatre access, staffing and efficiencies.
- Early and broad medical staff recruitment
- Transparent negotiations of Public in the Private surgery issue of conflict of intertest.
- Staff Wellbeing: High levels of fatigue, burnout and low moral in all areas.

- Written Examinations: held in ACT for last for three years. This was withdrawn in 2022. ACT RACS

MEETING

Variation in Sex Characteristics (Restricted Medical Treatment) Bill 2022

- Bill to restrict surgery/ medical management of individuals with variations in sex characteristics till the age of consent.
- An appointed committee would develop/ approve a treatment plan
- Criminal offence if there is any surgery performed without the consent of the committee.



- Inclusion of Hypospadias, Epispadias, Bladder Exstrophy
- Exclusion of Circumcision contradicts the premise of the bill
- Criminalisation of a surgical/medical procedure.
- Committee responsibilities to the individual, APHRA responsibility, external social agendas and bias in decision making, arbitration. Should be delt with MDT process.
- Medicolegal protection of clinicians.
- Concepts of consent in a child/ vulnerable individual
 - (No RACS position statement)
- Absence of mention parents in the decision making process
- Health Policy and Advocacy Committee (HPAC)



Proposed reforms to provide better care and support for people with variations in sex characteristics

Draft Legislation Consultation

- "Connect the Silos"
 - Clinical Nursing Co-Ordinator
 - Stomal Therapy Services
 - High Risk Fracture Clinic and Services
 - Improved co-ordination of In and Out of Hospital service
 - Improved engagement with NSW health for cross border service provision.
- Cultural Review Bullying and Harassment Policy and Engagement
