Dr Michelle Atkinson FRACS

Dr Michelle Atkinson is an orthopaedic surgeon and Chair RACS NSW State Committee. She is seeking the addition of Family Violence, recognition and management to surgical training.

Dr Andy Buck FACEM

Andy Buck is an emergency physician at the Royal Melbourne Hospital, one of Victoria's major trau-ma centres. He is the director of the Emergency Trauma Management (ETM) course and sits on the ACEM Trauma Emergency Medicine Network executive.

Professor Mayet Costello

Mayet is a manager in the Prevention and Response to Violence, Abuse and Neglect (PARVAN) Unit, NSW Ministry of Health. Her current role includes leading the Violence, Abuse and Neglect (VAN) Redesign Program and policy responsibility for sexual assault and medical and forensic responses to violence, abuse and neglect in NSW Health. Mayet has extensive experience in service delivery, policy, research, politics and management roles across the government and non-government sectors. This includes as Director, Research Program at ANROWS. Mayet has a PhD in policy response to male violence against women and qualifications in Social Work, Arts and Project Management.

Dr John Crozier AM CSM FRACS FRCS(T) FACRS

Dr John Crozier is a Vascular and Trauma Surgeon, on staff of Liverpool Hospital, South West Sydney, Chair Bi-National Trauma Committee of the Royal Australasian College of Surgeons. He is co-chair of Alcohol Change Australia and an Executive of the Australasian College of Road Safety. He had recently been invited to address the Australasian Liquor Licencing Forum. For decades, he has sustained advocacy to mitigate alcohol and gambling related harm.

Dr Lai Heng Foong BMBS, FACEM, MHS, BA (Hons)

Dr Foong, Senior Emergency Physician has a passion for Public Health, including Domestic violence, Disaster preparedness, Climate Change and Health, Indigenous Health and the social determinants of health. She holds a Master's in Public Health at Johns Hopkins School of Public Health, USA. She completed a research project on Domestic violence in patients presenting to the Emergency Department. Associate Professor Ken Harrison FANZCA

Ken is a trauma specialist and an anaesthetist at Westmead Hospital where he works with a team that tackles some of the most serious traumas in the state. He has also worked for 3 decades in pre-hospital medicine. He has been involved in trauma prevention and trauma education for most of his 39-year career and is the anaesthetic representative on the RACS trauma committee

Professor Kelsey Hegarty

Kelsey Hegarty is an academic general practitioner, joint Chair Family Violence Prevention at the University of Melbourne and the Royal Women's Hospital, leads NHMRC Safer Families Centre of Research Excellent and co-chairs Melbourne Research Alliance to End Violence against Women (MAEVe). Her research includes the evidence base for interventions to prevent violence against women; educational and complex interventions around identification of domestic and family violence in primary care settings and early intervention with men, women and children exposed to abuse. She led development of the Royal Australian College of General Practice White Book on Abuse and Violence and a GP learning module. She has developed an innovative domestic violence curriculum for health practitioners.

Dr Sally Langley FRACS

Dr Langley is a plastic and reconstructive surgeon based in Christchurch, Aotearoa New Zealand. Her work has covered the whole spectrum of plastic surgery including craniofacial, cleft lip and palate, head and neck, paediatric, reconstructive including microsurgery, hand surgery, as well as skin cancer and breast surgery. She has been involved with surgical education and training and was an examiner in plastic and reconstructive surgery. Aotearoa New Zealand deputy Chair Court of Examiners, which conducts the Fellowship exam of the Royal Australasian College of Surgeons (RACS), former President of the New Zealand Association of Plastic Surgeons, past Chair RACS Professional Standards and Development Board, Dr Langley is currently RACS President.

Ms Marlene Lauw

Marlene Lauw, a Wiradjuri and Ngunnawal woman, has extensive experience working with Aboriginal communities providing support, counselling and advocacy. Marlene holds specialised skills and knowledge in competency-based training, supervision and workforce development in the area of trauma, healing, family violence, sexual assault and child protection. Marlene explores and integrates Aboriginal worldviews, trauma informed care and healing frameworks in course design and delivery for Aboriginal and non-Aboriginal practitioners working in clinical, community and policy to increase professional capability in responding to the unique needs of Aboriginal people through respectful and safe collaboration. Making change and improving policies and strategies for working with Aboriginal people across the whole of sector is Marlene's core business and passion.

Dr Joe McGirr Independent Member for Wagga Wagga

Dr Joe McGirr has worked in regional NSW for more than 30 years, firstly in emergency medicine, then in health and hospital management and university administration before entering politics. Dr Joe was elected Member for Wagga Wagga on 8 September 2018, following an historic by-election.

He was re-elected into the 57th Parliament of NSW, six months later. Dr Joe's dedication to service for the needs of the community continues in his representation as the Independent voice of the electorate. Dr Joe works to ensure the community grows strongly in a safe and supported way.

He has extensive experience in rural and regional health in clinical practice, research, teaching and administration with all levels of government.

The Hon Natalie Ward MLC

Chair Joint Select Committee on Coercive Control – in an Australian-first, the committee unanimously recommended that coercive control be criminalised along with 23 recommendations relating to domestic abuse in 2021. This experience provided a unique opportunity to engage with a wide range of stakeholders which Natalie brings to her role as Minister for Women's Safety and the Prevention of Domestic and Sexual Violence.
