

#### Of 250 participants, 32.4% had a history of IPV in their lifetime

and disclosed this at their initial orthopaedic clinic appointment.

Twenty-one participants 12.4% who did not disclose abuse at the initial visit disclosed IPV during the follow-up.



The high prevalence of intimate partner violence in orthopaedic fracture clinics as compared with other medical specialties confirms the need for orthopaedic surgeons to be aware of the issues related to intimate partner violence and to recognize opportunities to assist women experiencing intimate partner violence.
