#### Welcome

The President welcomed those present to the Annual General Meeting.

#### 1 Confirmation of Minutes of the AGM held on 10 May 2018

On the motion of Mr John Batten seconded by A/Prof Julie Mundy:

#### It was RESOLVED:

That the minutes of the Annual General Meeting of Fellows of the Royal Australasian College of Surgeons held in Pyrmont Theatre, Sydney Convention & Exhibition Centre, 14 Darling Drive, Sydney NSW 2000 on Thursday 10 May 2018 at 5.30 pm be confirmed.

#### 2 Report from the President

The President referred to the governance and management section in the circulated 2018 annual report and highlighted the following:

#### Appointment of CEO Mr John Biviano

The President announced a separation agreement had been signed with the previous CEO and noted the appointment in March 2019 of Deputy CEO Mr John Biviano as CEO, replacing Ms Mary Harney. John is working with the Executive Leadership Team and staff to implement the College's 2019-2021 Strategic Plan.

#### **Building Respect and Improving Patient Safety**

RACS has formalised partnerships with 35 hospital groups, universities and others involved in training and delivery of surgical care to continue the program of Building Respect and improving Patient Safety in keeping with the College's commitment made in 2015.

An independent evaluation of the RACS' Building Respect and Improving Patient Safety program is underway. It has become evident that RACS has limited powers to act upon complaints, particularly, anonymous complaints. Therefore the College is actively working with hospitals and regulators to share information and facilitate the taking of prompt appropriate action by those with the powers to do so.



#### RACS' Relationship with the Specialty Societies

The President, incoming President, CEO and Executive General Manager Education undertook a comprehensive consultative process with the Specialty Training Board Chairs and the leadership of the Specialty Societies early in 2019. Renewed service agreements between RACS and societies are being prepared for the ongoing delivery of training in the nine surgical specialties in which the College is accredited to award the Diploma of Fellowship.

#### **Rural and Remote Surgical Workforce**

RACS' Specialty Training Boards were working with others, including the Commonwealth appointed Rural Health Commissioner, to assist selection into training and workforce distribution of surgeons wishing to work in rural and remote areas.

#### **Excessive Fees**

RACS continues to state its position that charging extortionate fees is exploitative and unethical and to advocate with others in the profession for better information to patients and their GPs to enable informed financial consent. RACS will continue to apply sanctions where appropriate and encourage adherence to the RACS Code of Conduct.

#### Acknowledgement of Fellows and Trainees in Christchurch

The President paid tribute to the selfless, untiring work of surgeons and trainees who assisted victims of the 15 March 2019 attacks on worshippers in mosques in Christchurch.

The President thanked his Council colleagues, Fellows and staff for their support during the past year.
