- 3.2.2 To champion initiatives across all relevant RACS portfolios, specialty societies and specialty training boards/committees in accordance with the Building Respect Action Plan (2022) and associated work plans
- 3.2.3 To liaise and support RACS portfolios in the development and implementation of relevant policies and procedures.

### 3.3 Powers

The Building Respect Improving Patient Safety Operational Group will make recommendations to the Council in relation to the objectives, duties and responsibilities listed above.
