1. PURPOSE AND SCOPE

The policy provides the criteria for the conduct of the Surgical Education and Training (SET) Generic Surgical Science Examination (GSSE) for a SET trainee.

The GSSE is a summative assessment of a candidate's knowledge, understanding and application of anatomy, physiology and pathology in which is fundamental to safe and comprehensive surgical practice.

2. KEYWORDS

Surgical Science Examination, GSSE, Examinations, Surgical Education and Training

3. BODY OF POLICY

3.1. Format of the Examination

- 3.1.1. The examination consists of two segments and is conducted over two consecutive days:
 - a. Paper 1 consists of 80 generic anatomy questions
 - b. Paper 2 consists of 60 physiology and 65 pathology questions.

3.2. Eligibility to Present for the Examination

- 3.2.1. Trainees in a SET program, whether in active, deferred or interrupted training are eligible to apply for the GSSE in February and June.
- 3.2.2. A SET trainee is not permitted to apply for the GSSE held in October.

3.3. Application

- 3.3.1. The examination dates and application closing dates are published on the RACS website.
- 3.3.2. A candidate must apply through the online registration system, via the RACS website and pay the examination fee in full at the time of registration.
- 3.3.3. An application outside the published timeframes will not be accepted.

3.4. Time Limitations and Number of Attempts

- 3.4.1. The examination must be passed within the two (2) year period from the commencement of the trainee's first clinical rotation or period of accredited research. The two year time limit will be extended by that period where a trainee has interrupted their training and during which time sittings of the Generic Surgical Sciences Examination are held, unless one or both of those sittings have been attempted.
- 3.4.2. A maximum of four (4) attempts at the Generic Surgical Sciences
 Examination are allowed by any individual trainee. This includes sittings of
 the examination while in clinical training, accredited research, on
 interruption or deferred from training.
- 3.4.3. Trainees who have not passed the examination after four (4) attempts or within the period specified in 3.4.1 (whichever is sooner) will be dismissed from the training program.

3.5. Trainees who Transfer between Specialty Training Programs

- 3.5.1. The examination is generic to all specialties.
- 3.5.2. A successful attempt will carry over should a trainee transfer between specialty training programs.

3.6. Conduct of the Examination

- 3.6.1. The conduct of the examination is the responsibility of the Surgical Science Examination & Clinical Examination (SSE&CE) Committee.
- 3.6.2. The curriculum for the GSSE is published on the RACS website.
- 3.6.3. Invigilators play a central role in ensuring that the security of this examination is maintained at all times.
- 3.6.4. When necessary, candidates will be segregated in a separate room to avoid contact between candidates who have completed an examination segment and those who have not.
- 3.6.5. By applying to present for the GSSE, the candidate is agreeing to this policy and the Generic Surgical Science Examination Rules for Candidates.
- 3.6.6. Disruptive behaviour by a candidate in any segment of the examination will be investigated as misconduct. If a candidate is reported to be causing a disturbance during the examination, he/she will be removed from the examination room.
 - The candidate involved will not be given extra time at the end of the examination for any reason including time taken to address the incident.
 - An examiner or other person supervising an examination segment will complete an incident report for consideration by the SSE&CE Committee.

3.7. Prohibited Equipment or Materials

- 3.7.1. Equipment or materials which are not permitted to be taken into an examination room by a candidate ("prohibited equipment or materials") includes but is not limited to:
 - a. all watches, mobile phones, calculators, portable computers, tablets or other electronic audio-recording devices (e.g. audio-recording wrist bands, pens, spectacles, mp3 players, IPods, IPads, etc.).
 - b. notes, books, textbooks or other materials.
- 3.7.2. A candidate who takes prohibited equipment or materials into an examination room will be informed that he or she must leave the examination room immediately and will not be permitted to take further part in the examination.
- 3.7.3. The candidate's result for the examination will not be approved and any examination fees paid will be forfeited as per terms stipulated in clause 3.14.
- 3.7.4. An examiner or other person supervising an examination segment will complete an incident report for consideration by the SSE&CE Committee.

3.8. Cheating

- 3.8.1. Cheating is defined as, but is not limited to:
 - gaining or attempting to gain access to any materials such as specimens or images, or patients involved in the examination, prior to an examination;
 - copying, or allowing another candidate to copy, answers during the course of an examination;
 - disseminating or making available questions or answers to another candidate or prospective candidate relating to the current examination:
 - d. procuring knowledge of the questions, and their answers, from anyone before the examination.
- 3.8.2. An invigilator, Examiner or other person supervising an examination segment will, upon identifying suspected cheating during the examination, complete an Examination Incident Report for consideration by the SSE&CE Committee.
- 3.8.3. The candidate involved will not be given extra time at the end of the examination for any reason including time taken for discussions with the person who has identified the incident.

3.9. Report of prohibited equipment or materials or cheating

- 3.9.1. Upon receipt of an Examination Incident Report of the taking of prohibited equipment or materials into an examination room or cheating, the Chair of the SSE&CE Committee transmit the report to the relevant Specialty Training Board for consideration pursuant to the RACS Misconduct policy and the Board's regulations;
- 3.9.2. If a report on the taking of prohibited equipment or materials into an examination room or cheating is received by the SSE&CE Committee, or if a Specialty Training Board receives the report directly:
 - a. prior to the examination taking place; the candidate's application for presenting to an examination will be withheld until such time an investigation has concluded; if an allegation is upheld in addition to any penalty imposed by the relevant authority or Training Board, the candidate's application will not be valid and the entire examination fee paid will be forfeited as per terms stipulated in clause 3.14 of this Policy.
 - b. during the examinations and prior to the examination results being made available to candidates - the examination result will be withheld until such time as an investigation has concluded; if the allegation is upheld, in addition to any penalty imposed by the relevant authority or the Specialty Training Board, the examination result will not be approved and the candidate will be regarded as having an unsatisfactory performance.
 - after the examination results have been made available to candidates; if the allegation is upheld, in addition to any penalty imposed by the relevant authority or the Specialty Training Board, the

examination result will be withdrawn and the candidate will be regarded as having an unsatisfactory performance.

3.10. Privacy and Confidentiality

Any person involved with the GSSE and a candidate presenting for the examination shall treat as strictly confidential any materials, images, content or discussions of any examination component viewed or discussed for the purposes of conducting the GSSE. Any breach of confidentiality by any candidate may be treated as cheating and dealt with according to RACS process.

3.11. Special Circumstances Relating to Examinations

Refer to policies EDA-EXA-034 Special Consideration and EDA-EXA-035 Reasonable Adjustments for Disability.

3.12. Marking System

An overall pass standard for each examination is based on a standard setting evaluation and on the difficulty of the questions in each examination.

- 3.12.1. To achieve an overall pass, a candidate must achieve all of the following:
 - a. a minimum pass standard in each discipline component (anatomy, physiology and pathology) during the same sitting, and
 - a combined discipline component score equal to or exceeding the overall pass standard.
 - c. Achieving a minimum pass standard in each discipline may not equate to achieving the overall pass standard for the examination.
 - a discipline component pass from a previous exam attempt cannot be carried forward.

3.12.2. Minimum Standard Pass

A candidate, who falls within the following criteria in any two attempts at the exam, will be elevated to a pass on the second occasion.

- a. a minimum pass standard in each discipline component (anatomy, physiology and pathology) during the same sitting, and
- a combined discipline component score no less than one error width below the overall pass standard.

3.12.3. Component Failure

Failure to achieve the minimum pass standard in any discipline constitutes a component failure resulting in a failure of the entire examination regardless of the overall score achieved.

3.13. Results

- 3.13.1. The results of the GSSE are approved by the SSE&CE Committee.
- 3.13.2. A candidate will be awarded a result of pass or fail.
- 3.13.3. Both segments (Paper 1 and Paper 2) of this examination are considered to determine the overall examination result.
- 3.13.4. The candidate will be informed of his/her result via email.

3.13.5. Results of this examination will be communicated directly to the relevant Specialty Training Board.

3.14. Withdrawals and Refunds

- 3.14.1. A candidate who wishes to withdraw from the examination must do so via the RACS website and online withdrawal form.
- 3.14.2. A percentage of the examination fee will be refunded in accordance with the following timeline.
 - A candidate will be refunded 95% of the examination fee if notification of withdrawal from the examination is received prior to the application closing date.
 - b. A candidate will be refunded 50% of the examination fee if notification of withdrawal from the examination is received after the application closing date and more than 10 business days prior to the commencement of the first scheduled day of the examination.
- 3.14.3. A candidate will not receive a refund if notification of withdrawal from the examination is received fewer than 10 business days prior to the commencement of the first scheduled day of the examination.
- 3.14.4. A candidate will not receive a refund for non-attendance at the examination.
- 3.14.5. A candidate will not receive a refund if he/she is prevented from participating in the examination as a result of taking prohibited equipment or materials into an examination room or cheating or misconduct.
